STIPULATION AND [PROPOSED] ORDER

Pursuant to Section V.B of the Order of Preliminary Injunction and Other Emergency Relief Upon Consent (Docket No. 23) (“Order”), Plaintiff U.S. Securities and Exchange Commission (“SEC”) and Defendant Glenn C. Mueller (“Mueller”), through their undersigned counsel, hereby submit this joint filing and agree and stipulate as follows:

1. Mueller is permitted to make a single, one-time withdrawal in the amount of \$2,569 from the account ending 2410 at First American Bank, for the sole purpose of his receipt of social security benefits paid into the account after entry of the Order.

2. Mueller’s account ending 2410 at First American Bank shall otherwise remain subject to the asset freeze provisions of Section V.A of the Order.

3. This Stipulation may be executed in counterparts, and electronic or facsimile signatures shall be deemed equivalent to original signatures. Concurrence in the filing of this document has been obtained from the signatories below.
