RECEIVER'S NOTICE OF SEVENTH INTERIM DISTRIBUTION AND ILLINOIS TAX WITHHOLDINGS

NOTICE TO ALL RECIPIENTS: THE DEADLINE TO OBJECT TO THIS NOTICE IS
JUNE 16, 2025

N. Neville Reid, not individually, but solely as the Court-appointed receiver (the “Receiver”) for the Estate of Defendant Northridge Holdings, Ltd. and its related entities and affiliates as more particularly set forth in the Receivership Order (as defined herein) (collectively, the “Receivership Defendants,” and the assets of such entities as more particularly set forth therein, the “Receivership Assets,” and such estate the “Receivership Estate” and such administration, the “Receivership”), and pursuant to the powers vested in him by the *Order Appointing Receiver* entered by the Court on September 12, 2019 as amended [Dkt. No. 22, 108, 215] (collectively, the “Receivership Order”) and the Order Granting Receiver’s Motion for an Order Approving Distribution Plan and Certain Other Related Relief [Dkt. No. 288, see ¶ 16] (the “Distribution Plan Order”), hereby provides notice of a Seventh Interim Distribution and Illinois Tax Withholdings as follows:

NOTICE

1. **PLEASE NOTE:**

a. **IF YOUR ADDRESS AND/OR PAYMENT INSTRUCTIONS HAVE CHANGED SINCE THE LAST DISTRIBUTION, PLEASE CONTACT THE RECEIVER AND HIS COUNSEL TO ADVISE THEM OF ANY CHANGE(S).**

b. ***If you previously confirmed special payment instructions with the Receiver and/or his professionals/staff, those payment instructions will be followed for the Seventh Interim Distribution.***

c. **Please visit northridgereceiver.alixpartners.com to contact the Receiver and his professionals with any updates and/or questions.**

2. **Total Amount of Seventh Interim Distribution: \$4,000,000.00.** This distribution is intended to be made shortly after June 16, 2025.

3. **Payment of Investor Claims (Class 4):** A summary of Seventh Interim Distribution Payments on account of allowed Investor claims is set forth in **Exhibit A** (the “**Investor Claims Summary**”). To the extent an Investor had IRA investments (or multiple IRA investments) and non-IRA investments (designated as “Cash/IRA” or “Mult. IRA” on **Exhibit A**), payment pursuant to the proposed allocation is set forth in **Exhibit B**.

4. **Payment of Non-Investor General Unsecured Claims (Class 5):** A summary of Seventh Interim Distribution Payments on account of allowed Non-Investor General Unsecured Claims is set forth in **Exhibit C** (the “**Non-Investor Claims Summary**”).

5. **PLEASE READ:** If you are an Investor and **not** scheduled to receive a distribution in **Exhibit A**, your account is listed in **Exhibit D** along with the percentage recovery you have received to date (determined by using Cash-In, Cash-Out ***plus*** the amount you received from previous receivership distributions). You are not receiving amounts from the Seventh Interim Distribution because “rising tide” methodology is being used. All investors that have received in excess of 87.04% including the Seventh Interim Distribution have received more by way of pre- Receivership and post-Receivership distributions than the Investors who are scheduled to receive a distribution in **Exhibit A**. You will begin receiving distributions (from potential future distributions) when the other Investors “catch up” to your recovery percentage.

6. **Illinois Tax Withholdings:** As set forth in Receiver’s Motion For an Order Authorizing Amendments to Distribution Plan [Dkt. No. 306] and order approving same [Dkt. No. 312], the Receiver has been reserving **\$454,229.00** collectively on behalf of out-of-state Investors in the amounts set forth on **Exhibit E**. The Receiver has determined that there has been sufficient finality and closure to distribute such amounts and will distribution such amounts at the same time as the Seventh Distribution. **An Investor may not be participating in the Seventh Interim Distribution and appear on Exhibit D, but may be receiving a distribution of the Illinois Tax Withholdings.**
