2. **Total Amount of Eighth Interim Distribution: \$1,500,000.00. This distribution is intended to be made shortly after December 18, 2025.**

3. **Payment of Investor Claims (Class 4):** A summary of Eighth Interim Distribution Payments on account of allowed Investor claims is set forth in **Exhibit A** (the “**Investor Claims Summary**”).
